## Description

As a Jesuit institution founded in 1843, Saint Louis University School of Law strives to foster an environment of academic excellence and a commitment to public service and professionalism. With an accomplished faculty and a diverse curriculum designed to prepare students for all areas of legal practice, the school provides an ideal environment for those committed to succeeding. Through its Center for Health Law Studies, it also offers one of the premier health law programs in the nation, along with specialized centers in employment law and international and comparative law. Whatever the interest — corporate, criminal, employment, entrepreneurship, finance, health, international, intellectual property, tax, real estate or litigation — the SLU School of Law can help students achieve their desired career goals.

In the fall of 2013, the School of Law moved to a new building, Scott Hall, in the heart of downtown St. Louis. The building provides top-rate facilities to our students and allows them to integrate their legal education with the downtown legal community.

The School of Law offers full-time day, part-time day and part-time evening programs. Students are presented with a variety of opportunities for experiential education. Experiential learning courses are available to all students after the first year of study. Students have options including simulated arguments before the Supreme Court, contract-drafting and participating in our legal clinics. Under supervision from trained faculty, the legal clinics allow students to represent clients in need at court. Additionally, students have opportunities to clerk for judges and participate in externships at various corporations and government agencies. Our students annually provide more than 47,000 hours of free legal services to the community through our clinic programs.

In the spirit of the Jesuit tradition (<https://www.slu.edu/about/catholic-jesuit-identity/>) of “men and women for and with others,” there is a focus on the commitment to public service as part of the legal profession. Public service projects begin at orientation and opportunities continue throughout the program.
