# **EMERGENCY MANAGEMENT,** B.S.

Saint Louis University's online Bachelor of Science in Emergency Management program equips students with the knowledge and skills needed to administer aid and promote resilience in their communities during disasters large and small. SLU's program takes a multidisciplinary approach that focuses on all sectors recognized by the Federal Emergency Management Agency (FEMA) and the Department of Homeland Security.

This career-centric curriculum covers the core phases of emergency management, from mitigation and preparedness to response and recovery. Students will learn from instructors with knowledge of the field and professional experience, including practitioners who continue to operate within one of the emergency management sectors. The knowledge and tools students will acquire are applicable in the private and public sectors.

As part of the School for Professional Studies, this 120-credit degree program offers future and current leaders like you a flexible option to meet your personal career goals. With six accelerated, eight-week terms offered each year through SLU online, you can begin working toward your degree at any time, making advanced education more accessible for working professionals.

Certification as an associate emergency manager (AEM). Many employers require this professional certification for posted new positions.

Honorably discharged veterans, active-duty military members, reserve members and first responders qualify for a reduced tuition rate of \$295 per credit hour for any **undergraduate** program through the School for Professional Studies.

- Completed application

- Minimum transfer cumulative GPA of 2.5 (unless qualified for conditional admittance)
- · Official transcript from the most recent institution attended

Upon admission, a new student must successfully complete a virtual meeting with their academic coach to be enrolled in first-term coursework.

The School for Professional Studies welcomes adult learners seeking an undergraduate education after life circumstances have interrupted their educational journeys. Adult life circumstances, for the purposes of admission, would include individuals with at least one of the following characteristics:

- · Delayed enrollment in post-secondary education
- · Attends part-time for at least part of the academic year
- · Works full-time (35 hours or more/week) while enrolled
